- Relevant Recognition of Prior Learning (RPL) qualification(s) at QF Level 3 or above; or
- Other relevant verifiable prior learning and/or work experience that is/are deemed appropriate by respective Programme Board; or
- Mature applicants, i.e. those aged 21 or above, with at least 2 years' relevant working experience and may be required to pass an entrance assessment.
