### VTC signs MoU with Lai Sun Group To Advance VPET Talent Development

The Vocational Training Council (VTC) has signed a Memorandum of Understanding (MoU) with Lai Sun Development Co Ltd (LSD) and Lai Fung Holdings Ltd (LFH) to strengthen collaboration in Vocational and Professional Education and Training (VPET). This strategic partnership aims to enhance curriculum design, provide internship opportunities, and jointly promote VPET to meet industry needs. Under the agreement, LSD and LFH will collaborate with VTC to enrich programmes such as Higher Diploma in Retail and E-commerce Management, Higher Diploma in E-commerce, and Higher Diploma in Real Estate and Property Management. Initiatives include seminars, guest lectures, joint projects, and internship placements, offering students real-world exposure and practical experience.



This partnership underscores a shared commitment to nurturing talent for Hong Kong and the Greater Bay Area, ensuring students are well-prepared for careers in retail, real estate, and property management.

### VTC Signs MoU with Hong Kong Airlines To Nurture Aviation Talent

14 October 2025

VTC and Hong Kong Airlines have signed an MOU on 14 October 2025 to collaborate on nurturing talent for the industry. Hong Kong Airlines will support students in VTC's Higher Diploma programmes in Aviation and Logistics, Aviation Inflight and Passenger Services, and Airport Operations Management through scholarships, internships, and job opportunities. The partnership also includes career talks and company visits to enhance industry exposure. This collaboration is an important initiative under the Vocational Professionals Admission Scheme (VPAS), which aims to attract non-local students to designated Higher Diploma programmes and encourage them to stay and develop their careers in Hong Kong, thereby strengthening the city's key industries with new talent.

## Hands-On Customs Training for IVE Business Students

On 17 November 2025, Year 1 students of the Higher Diploma in Management for Disciplined Services had an exciting learning experience at the Hong Kong Customs College. ## Professional Seminar

### ALMAC 2025: Inspiring Future Talent in Logistics and Transport

18 November 2025

Around 100 students from the Higher Diploma in Aviation and Logistics and the Higher Diploma in Aviation Services and Transport Studies attended the Asian Logistics, Maritime and Aviation Conference (ALMAC) at the Hong Kong Convention and Exhibition Centre in Wan Chai. The conference provided an invaluable opportunity for students to gain insights into the latest developments in the aviation and logistics industries and to connect with global experts. A major highlight was the introduction of the Port Community System (PCS), a government-led digital platform spearheaded by the Transport and Logistics Bureau in collaboration with the Hong Kong Logistics and Supply Chain MultiTech R&D Centre (LSCM). The PCS aims to connect stakeholders across both the maritime and air transport communities, providing a single electronic window for data exchange. By enhancing cross-sector information interconnectivity, PCS supports cargo clearance, logistics coordination, and supply chain visibility, while driving smart port and smart airport development. This initiative strengthens Hong Kong's competitiveness and reinforces its position as an international logistics hub.



In addition to learning about PCS, students were introduced to new advancements in drone technology and electric Vertical Take-Off and Landing (eVTOL) aircraft, which are expected to reshape the future of aviation and logistics with smart mobility and sustainable solutions. Students also had the chance to visit exhibition booths hosted by leading companies, gaining first-hand exposure to industry practices, emerging technologies, and business models. The experience broadened their horizons, deepened their understanding of industry trends, and inspired them to contribute to the future development of Hong Kong's aviation and logistics sectors.
